Mr. Thompson would like to bring Mr. Highley back to Collegeville Borough due to his knowledge of the projects occurring in Collegeville and his ability to work with the public. Mr. Highley's new firm in LTL Consultants, Inc. Mr. Thompson requested that Borough Council approve the proposal for inspection services from LTL Consultants, Inc. The hourly rate is the same as KMS. MOTION by Mr. Braun to approve the Inspection Services Proposal from LTL Consultants, Inc.; second by Ms. Kernen.
