WARNING: Any person, firm, or corporation who violates or permits the violation of any provision of this Article shall, upon conviction of a summary offense before a District Justice, be sentenced to pay a fine not to exceed \$1,000 per violation with costs of prosecution and, in default of the payment of such fine and costs, be sentenced to undergo imprisonment to the extent allowed by law for the punishment of summary criminal offenses

NOTE: In the event that there are any material or substantial changes in the nature or character of the goods, wares, or merchandise to be sold, offered for sale, or for which orders are to be solicited, or in the selling or soliciting methods to be used, or in the event that an agent or representative not listed on the application is to be assigned to perform any of the functions or activities enumerated in Section 6-2122 or 6-2123 of Ordinance #547, such changes shall be reported to the Chief of Police, who shall amend the application in accordance with such changes, and after such amendment, any agent or representative, whose name has been added to the list, may procure a copy of the permit issued his employer or principal by complying with the conditions set forth in Section 6-2125 of Ordinance #547.
